Title of IFIB : On site Engineering Support for NEC CCIS upgrade - MAGNUM.

Requirement 1) JWC is seeking on site engineering support for developing an enterprise type JavaScript application, complementing the existing NEC CCIS client/server solution. The new client is based on ExtJS. The existing Java client is form-based, and the user interface is specified using an in-house tool. As part of this task, the in-house tool must also be updated to create content for the new JavaScript application. Skills required include JavaScript, preferably ExtJS, as well as Java EE in order to build functionality on both the server and client tiers.

2) System administration support for the System Management and Test Section (SMTS) team in the NEC CCIS System Support Centre (SSC).
