The GTCCI has been recognized and is operated in accordance with the Presidential Decree 288/5/9/2001.

Operates as an independent entity, non-profit, under private law.

### **PURPOSE OF THE CHAMBER**

The promotion and the development of commercial, economic, business and cultural relations between Greece and Turkey developing activities related to the above items.

The GTCCI has developed excellent relationships with Authorities, Ministries, Organizations, Institutes and Chambers in both countries in order to make a reliable mechanism to promote the bilateral trade and investment offering to its members and to third reliable services.

### **SERVICES OF THE CHAMBER TO THE MEMBERS:**

#### **Weekly e-newsletter**

Inform each week with e-newsletter for the economic-political-business news in Turkey and Greece, business events and collaborations.

#### **Organizing events**

The chamber organizes and coordinates events, business, social and cultural content, inviting prominent personalities of the two countries that contribute to the overall promotion of the relations between the two countries.

#### **Collaboration with other Chambers**

The GTCCI is working with all the bilateral – commercial – industrial – small and medium sizes industries and chambers of Greece and Turkey, creating opportunities for collaboration as well as for the Countries of Central Asia.

#### **Mediation**

#### **Business missions**

It performs over 16 sectors business missions with Greek businessmen in Turkey with Turkish respective counterparts for establishing business relations.

#### **International Fairs**

- 1) Participates in 45-50 international fairs annually accompanying Greek businessmen.
- 2) Participates in 15 international exhibitions in various cities of Turkey with Greek stand area (under the GTCCI name), housing a Greek manufacturing companies to promote their products in Turkey and Central Asia.

#### **Participation in conferences**

The GTCCI participates in international conferences and speeches informing about the possibilities of cooperation between Greek and Turkish businessmen.
